Soul Alignment Process

AWARENESS

LIGHT CENTERS

SOUL REHABILITATION

All souls who violate Universal Law will be seen by the Court of Universal Law & guided to a Light Center for soul rehabilitation for an agreed upon amount of time. Here, the soul will receive the education & training in order to obtain the soul growth and the lessons.

SOUL HEALING

Rehabilitation Centers

All Jails/Prisons will be transitioned into Rehabilitation Holding Centers. These centers will treat every being as their higher self & will simply act as a care center before the being can be seen in the Universal Court of Law to be heard, educated & then transferred to a Light Center for healing.

TRAINING PROGRAMS

The new system of Universal Courts of Law will be implemented first through training programs.
